1. **THIS COURT ORDERS** that this action be discontinued without costs and without prejudice to putative class members other than William Kennedy (in respect of which his individual action shall be dismissed with prejudice).


2. **THIS COURT ORDERS** that notice of the discontinuance of this action, including a copy of the within Order, be published on the website of counsel for the Plaintiff, as well as sent directly to every putative Class Member who has contacted counsel for the Plaintiff in connection with this action;

3. **THIS COURT ORDERS** that the notice of discontinuance set out on paragraph 3 above shall set out that the action has been discontinued and that the applicable limitation period for any potential claims related to the issues raised in this action will continue to run as of the date of the discontinuance;

4. **THIS COURT ORDERS** that the limitation periods for putative class members which have been suspended since the issuance of the Statement of Claim in this action, are no longer suspended and will continue to run as of the date of this Order discontinuing the action;

5. **THIS COURT ORDERS** that an honourarium payment to William Kennedy, in the amount of \$1,000, is hereby approved pursuant to s 29 of the *Class Proceedings Act, 1992*, SO 1992, c 6; and,

6. **THIS COURT ORDERS** that there shall be no costs of this motion.
